I. GENERAL INFORMATION

LOCATION AND DATE

The Jamboree will be held on October 2 - 4, 2020, at Boxwell Scout Reservation in Lebanon, TN.

REGISTRATION AND COSTS

The cost to attend the 100th Anniversary Council Jamboree is \$20.00 per Scout BSA, Venturer, or Sea Scout when paid by Friday, September 18, 2020. After September 18 the cost for participants will be \$25.00. NO FEE will be charged for leaders. Preregistration will close at 3:00pm on Sunday, September 27.

Registration for the 100th Anniversary Council Jamboree will be available on the Middle Tennessee Council website, which can be visited at:

ARRIVAL AND CHECK-IN

All units will be checked in as they arrive and assigned a campsite. Units cannot be guaranteed campsites next to other specific units. All units should Be Prepared and work out standards for providing Youth Protection prior to arrival. Coordination with other units in the sub-camp area may be required. Cars will be allowed into camp to drop off camping gear and supplies for only a few minutes. Once the car is unloaded it will need to be moved to the parking area so other cars can enter and unload. We must keep the area clear and moving for units to arrive in a safe and efficient manner.

PARKING

Parking will be allowed in designated areas only. You may drive to your campsite for unloading and loading unit gear only. <u>Each unit will be allowed just</u>

one vehicle, with or without an enclosed unit gear trailer, in their campsite. This vehicle must remain parked until departure on Sunday after check-out has been approved. Any extra vehicles will be towed at the owner's expense. Roads must remain open at all times to allow access by emergency vehicles.

No RV's (motorhomes, camping trailers, or campers) are allowed and will be refused entry. Please carpool to conserve parking.

CAMPSITES AND ASSIGNMENTS

Campsites will be pre-assigned by Jamboree staff based on unit pre-registration numbers. Each unit will have a designated area marked out for use. Please respect the boundaries set for your unit and not encroach on neighboring units. We will do our best to accommodate any additions to your unit who may have decided to attend after pre-registration closes. If there are space conflicts that cannot be amicably resolved, contact your subcamp commissioner.

Unit campsites should be organized and maintained in accordance with BSA guidelines. Individual units are responsible for all of their camping equipment and supplies. Generators will not be allowed in campsites. Smoking in the sub-camp areas is prohibited. The U.S. Flag, Tennessee state flag, and unit or patrol flags are encouraged to be displayed in sub-camp areas. Please use appropriate flag etiquette when displaying flags.

TENTS

All tents should be anchored to the ground and placed in a neat order within the assigned camp space. All tents must have the assigned campsite number and occupant names posted on the front of the tent for quick identification in case a camper must be located. Each unit will need to provide their

own signage in their camp area. Valuables should be kept at home or locked in a vehicle. The Middle Tennessee Council and Jamboree staff are not responsible for lost, stolen or misplaced valuables.

Separate tenting arrangements for adult males and females and youth males and females are required. Youth sharing tents must be no more than two years apart in age. Youth and adults must tent separately. Spouses may share tents.

CHECK-OUT AND DEPARTURE

Check-out is any time after Sunday morning Scouts Own Service, but <u>no later than 12:00pm.</u> No units may depart until after their campsite has been inspected and cleared to leave by a sub-camp commissioner. If a unit needs to leave prior to Sunday morning, they will need to make arrangements to have their campsite inspected and turn in completed Jamboree evaluations.

Unit leaders will need to use the checklist provided at the Friday night leader's meeting to ensure all tasks have been completed prior to requesting a commissioner to approve departure. Many units will be trying to leave within a short period of time. Please remain patient as the sub-camp commissioners work hard to approve your unit for departure. Check-out will include the following procedures:

- 1. Final Campsite Inspection: Your sub-camp commissioner will come to your campsite when ready for a final inspection. Your unit must wait at your campsite until after it has been ensured that all of your gear is packed up and the area has been patrolled for trash.
- 2. Evaluation Forms: The Jamboree evaluation form must be completely filled out and ready to be turned in during check-out. These evaluations are essential for us to create an ever-improving event. If you feel some major changes need to be made to future

Jamborees or if you want to praise a specific staff member, please include it in your evaluation.

UNSCHEDULED ARRIVALS AND DEPARTURES

Anyone arriving or departing from the Jamboree, at any time during the course of the weekend, must sign in and out at Camp HQ. We need to be aware of any changes in attendance for all adults and youth at the Jamboree in the event of an emergency.

MANDATORY LEADER MEETING FRIDAY NIGHT

After check-in, each unit will be expected to set up their campsite. At 10:00pm there will be a mandatory leader meeting for the Unit Leader or their designated assistant at the Jamboree HQ. At this time, units will receive pertinent information for the weekend's events. Special bulletins regarding changes to the program or schedule will be provided if need be. Staff will answer any questions or resolve any pertinent issues. If additional staffing assistance is required, units may be asked to volunteer.

JAMBOREE STAFF

The Jamboree staff are **volunteers** from throughout the council who have donated a great deal of time and effort to make this a successful event. They are ready to answer any questions and are interested in feedback on how to improve participant experience. Additionally, the volunteer staff will make every attempt to be fair and reasonable in all activities.

Our goal is to make it as much fun as possible for all participants. Your consideration and cooperation are appreciated when it becomes necessary for a staff member to take action or make a command decision.

JAMBOREE PATCHES

Each registered youth and adult leader will receive a Jamboree participant patch at the end of the weekend. These patches will be delivered to your unit upon completion of the check-out process/final inspection. Additional patches for parents or other attendees may be available for purchase at the onsite Trading Posts while supplies last.

CHANGES AND EVENT CANCELLATION POLICY

Our council refund policy states, <u>"If an activity is cancelled or postponed by our council or a district and the participant cannot attend on the alternate date, the full fee will be refunded."</u>

Refund of fees, outside of a deposit, will be processed on a sliding scale according to the following guidelines:

- Requests received 30 or more days before the event – will receive 100% of the total event fee, less a non-refundable deposit.
- Requests received 14-29 days before the event – will receive 50% of the total event fee, less a non-refundable deposit
- Requests received from 13 days before until the day of the event – will receive 50% of the total event fee, less a non-refundable deposit, only in the event of medical reasons (with doctor's verification), a death in the immediate family, or a natural disaster

No refund requests will be accepted after ten (10) days following the end of the applicable activity.

Approved refunds will be processed within thirty (30) days of their receipt in writing and made either by check or by credit card reversal, at the discretion of our council staff, to the original payer for individual registrations or the unit, in care of the reservation contact, for group reservations.

LOST AND FOUND

Items found are to be turned in at Camp HQ. Lost items may be claimed at HQ. Items not claimed by the conclusion of Jamboree will be sent to the Nashville Scout Office.

UNIFORMS AND DRESS CODE

Full field uniforms (Class A) are to be worn during the opening ceremony, arena show, and religious services. Activity uniforms (Class B) consisting of a unit t-shirt or other appropriate attire must be worn at all other times.

TRADING POST

The attached BULK pre-order form is designed to be used by the unit, not the individual. It must be received in the Scout Shop no later than Thursday, September 10. The Pre-Order Form is the only way to guarantee purchase of select commemorative Jamboree merchandise. Shop now and wear your Jambo tee shirts to the event! For your convenience the Trading Post will accept cash, checks, and credit cards. The on-site Trading Posts will offer jamboree tee shirts and caps, along with many other collectibles, assorted camping supplies, and other fun items. We will also have cold drinks and snacks. SUB-CAMP COMMISSIONERS

Each sub-camp area (Scouts BSA and Venturing/Sea Scouts) will have a pair of commissioners to assist with arrival and departure for the Jamboree. Subcamp commissioners will be on-site as you arrive and their contact information will be given at that time.

All sub-camp areas are subject to unannounced inspections at any time by sub-camp commissioners. Inspections will be completed to maintain health and safety standards throughout the Jamboree for the benefit of its participants and visitors.

SUB-CAMP COMPETITIONS

Each sub-camp area (Scouts BSA and Venturing/Sea Scouts) will be hosting a competition to be held throughout the weekend. More information will be communicated electronically and will be provided at the leader's meeting on Friday night.

II. HEALTH AND SAFETY

EMERGENCY INFORMATION

Jamboree emergency procedures will be covered with a handout provided at the Friday night leader's meeting.

FIRST AID

Units should provide their own first aid kit and have it visible and available to be used if need arises. In the event of injury or sickness, please report directly to a sub-camp headquarters tent, program area staff member, or any general staff member. These individuals will radio to emergency services for assistance. If the sick or injured is able to walk to the first aid station at Jamboree HQ, please take them directly to that location.

MEDICAL FORM AND MEDICATIONS

Every Scout and adult attending the Jamboree must be covered by Parts A & B of the BSA medical form. Unit Leaders must bring copies of the unit medical forms to the Jamboree. It is preferred that units keep their medical forms in an organized binder. Unit Leaders will need to provide medical forms in the event of an emergency. Any acute medical conditions are required to be reported to medical staff upon arrival. Those persons with diabetes or allergies must provide their own emergency kits and be prepared with proper

medication. Medications MUST be kept with unit leadership in a safe location. Also, any medications requiring refrigeration (i.e. insulin) must be stored with the unit.

The Guide to Safe Scouting requires all attendees to complete Part A and Part B of the medical form. All attendees include parents, youth, staff, and unit leaders. Part C is only for activities lasting longer than 72 hours and is not needed for the Jamboree.

ACTIVTY CONSENT FORM

Every youth under 21 years of age must have Part A: Informed Consent, Release Agreement and Authorization of the Medical Form signed by parents/ guardians, giving permission to participate at the event and for any medical treatments, hospitalization, etc.

BSA INSURANCE

Units should keep in mind that only registered Scouts and adult leaders are covered by the BSA insurance policy. The role of the Scout leader is to provide a safe and quality program for the Scouts. Any non-registered participants in attendance are responsible for themselves.

WEATHER AND LIGHTNING

All Scouts and adults should pack and prepare to come and participate at Jamboree, rain or shine. Bring tents, ponchos, pack covers, dining flies, ground cloths, and necessary clothing to be

comfortable in case of rain. Units are expected to have trained members in inclement weather camping procedures. Guidance on lightning will be provided during the Friday night leaders meeting.

SAFETY

Leaders must ensure that all participating in Scouting activities abide by the Scout Oath and Scout Law. Adult leaders and youth members share the responsibility for the safety of all participants in the program, including adherence to Youth Protection and health and safety policies.

Adult leaders are responsible for monitoring behavior and intervening when necessary. <u>All Youth Protection guidelines must be followed at the Jamboree.</u> Units will need to work together in certain situations to ensure there are two registered adult leaders with youth at all times.

The buddy system should be used at all times.

USE OF ELECTRONICS

Scouts should leave all cell-phones, tablets, radios, televisions, portable game devices, and other such electronics at home. Loss or damage of property is the sole responsibility of the individual who brought it. The use of smartphones, cameras, mirrors, drones, etc., in places or situations where privacy is expected is prohibited.

QUIET HOURS

All activities will be subject to quiet hours and lights out from 11:00pm until 6:00am each day. Leaders in each unit are responsible for enforcing these hours. A Scout is Courteous. After taps, every Scout is expected to be in his tent and quiet at that time. If you must move about in your own area after taps, do so quietly so that others are not disturbed. Roaming about the campgrounds or other campsites during quiet hours will not be tolerated.

RESPECTING OTHER UNITS' SITES

Everyone should respect other units' campsites. Please do not cross through another unit's site, but go around instead. While we encourage Scouts to visit other units, please announce your arrival and ask permission to enter before walking into a site. Show others the level of courtesy that you would like to be shown.

SANITATION AND BATHROOMS

All units should have a hand washing/sanitizing station setup within their site. Please respect the gender designation of all facilities at Boxwell Scout Reservation. Please respect them and keep them clean. Do not place trash or soft drink cans in the toilets. All units share in the responsibility of keeping the facilities clean and in working order. Please inform the staff of any problems immediately so it can be corrected before it becomes a major problem for all. It is a good idea to bring a few rolls of toilet paper with your unit and have campers take one with them to the toilets, just in case.

COOKING AND FIRES

Wood fires will be allowed in burn barrels only. Liquid fuel, propane stoves, and charcoal may be used in accordance with BSA policy. All use must be above ground. The Jamboree will follow the principles of "Leave No Trace." Coal ashes must be carried with you, no dumping of ashes anywhere on Boxwell. Any gas or liquid fuels are to be handled by adults only and stored away from tents and open flames/sparks. **Fire prevention must be top priority.**

Each unit or individual is responsible for their own meals. All food should be stored in animal proof containers and food areas clean when not in use to avoid attracting wildlife. It is up to the individual units to bring their own cooking and cleaning equipment. Units will cook in their own campsite. All

cooking areas should be a minimum of 10 feet away from all tents and other combustible materials. It is strongly suggested that time constraints of the Jamboree schedule should be kept in mind when planning meals. It is suggested that meals be simple and easy to clean up afterward so participants can spend the maximum time participating in Jamboree activities.

WATFR

Drinking water will be available at stations across the Jamboree. Containers will be needed to carry water to the campsites. No dish washing, bathing, or hand washing will be allowed at these faucets. Please do not waste water. Each Scout should come to the Jamboree with a water bottle to carry during the Saturday activity sessions.

FOOD SERVICE

Jamboree staff is working to partner with food vendors that will be established in a centrally located area. Confirmed vendors will be listed in the Jamboree information area on the website.

TRASH

All trash should be placed in garbage receptacles located throughout the sub-camp areas. A Scout leaves an area cleaner than they found it.

PROHIBITED ITEMS

Prohibited items include, but are not limited to:

- Alcohol: In accordance with BSA policy, no alcoholic beverages, drugs, or other controlled substances will be allowed to be present or consumed at the Jamboree.
- <u>Firearms:</u> For safety reasons, firearms, pellet guns, BB guns, bows and arrows, or slingshots of any kind are not allowed at the Jamboree.
- <u>Fireworks:</u> Absolutely NO fireworks are permitted at Boxwell Scout Reservation. Fire prevention must be a top priority.

PERSONAL PETS

No personal pets are permitted at the Jamboree except those used as service animals for campers with disabilities.

III. ACTIVITIES AND EVENTS

PROGRAM ACTIVITIES

What a weekend of activities we have planned for you! From group competitions to Scout skill challenges, from static displays to demonstrations, the Jamboree will be the pinnacle of fun in Middle Tennessee. Activities will be grouped together in age-appropriate areas and set out in an open statefair type layout. Participants can join in on their favorite Scouting activity, or see one of the many displays going on throughout the day that they can take back to their unit as an example of a fun outing.

Activities at the Jamboree will include tug-o-war, woods tools, survival skills, shooting sports, tomahawk throwing, STEM, and crafts. A full activity list for the Jamboree will be published as events are confirmed and can be found online at:

MIDWAY

Our Jamboree Midway will be a place where you can learn, ask questions, participate and have fun. The Midway will showcase many of our community business supporters, as well as EMS, Police, Fire Department, and Military who will have displays and

booths. We will have booths for each of our Council Scouting programs as well as national programs to provide information and ideas about scouting events and topics. Booths for our Council properties will be available for Scouts and parents to learn about activities and events at each location. Come out to see what Scouting has to offer and how you can participate!

TRADE-O-REE

Trade-O-Ree's are events held for the primary purpose of trading, buying, and selling Scout memorabilia. This will be the first Trade-o-Ree ever held in the Middle Tennessee Council and will feature Scouting collectors from around the United States. Be sure to stop by and see some great patches, neckerchiefs, and other Scouting pieces and feel free to bring your collection should you want to try and make a trade. Adults are prohibited from buying or selling patches with youth. Monitors will be onsite to oversee action and to prevent any unscrupulous transactions from taking place.

MIDDLE TENNESSEE COUNCIL MUSEUM

As part of the centennial celebration in 2020, the Jamboree will include a museum with a century's worth of history on the Middle Tennessee Council. Exhibits will include information on the people you know as namesakes of MTC properties such as E.B. Stahlman, Leslie Boxwell, Jet Potter, and many more. A timeline of MTC districts as well as exhibits of patches and other memorabilia from those

districts will be displayed. Grimes Canoe Base and Boxwell Reservation relics will also be on display.

The museum will have Council contingent photos, flags and relics from national jamborees and Philmont. A large collection of old BSA community strips from Nashville down to Lascassas will be there as well. You can see a complete collection of Wa-Hi-Nasa Lodge patches including the ultra-rare first lodge issue, of which only two are known to exist today. Historic trails, Scout circus memorabilia, vintage council newsletters, Eagle Scout banquets, Explorer encampments, and much more will be included in the museum. Don't miss it!

ALUMNI EVENTS

We are inviting all past and present alumni of various areas to come and partake in meet and greet events at the Jamboree. These will be short gatherings with a small presentation at the start of each event. After that, participants will be free to mingle and regale stories of Scouting adventures. 
